**PRIVACY NOTICE relating to TENANTS AND THEIR GUARANTORS (if any) of property  
let/managed by QUADRANT PROPERTY MANAGEMENT LTD**

This privacy notice explains what personal data (information) we hold about you, how we collect it, and how we use and may share information about you during our management of the flat you occupy or have agreed to act as guarantor in respect of, and after it ends. We are required to notify you of this information under the General Data Protection Regulation.

Please ensure you read this notice (sometimes referred to as a "privacy notice") and any other similar notice we may provide to you from time to time when we collect or process personal information about you. This privacy notice contains important information on who we are, how and why we collect, store, use and share personal information, your rights in relation to your personal information and on how to contact us and supervisory authorities in the event you have a complaint.

## 1. **WHO WE ARE**

Quadrant Property Management Ltd collects, uses and is responsible for certain personal information about you. When we do so we are regulated under the [General Data Protection Regulation](#) which applies across the European Union (including in the United Kingdom) and we are responsible as 'controller' of that personal information for the purposes of those laws.

In this privacy notice, references to "we" or "us" means Quadrant Property Management Ltd.

## 2. **DATA PROTECTION PRINCIPLES**

We will comply with the data protection principles when gathering and using personal information, as set out in our GDPR data protection policy.

## 3. **THE PERSONAL INFORMATION WE COLLECT AND USE: INFORMATION COLLECTED BY US**

In the course of letting/managing the property you occupy or have agreed to act as guarantor in respect of, we collect the following personal information when you provide it to us:

- Name, address, telephone numbers, email addresses, bank details of yourself and other occupiers of the property, employment and salary details, previous rent paid, passport, residency status.

The provision of the above personal data is required from you to enable us to perform our contract as managing agent appointed for and on behalf of the landlord. We will inform you at the point of collecting future information from you, whether you are required to provide the information to us.

## 4. **THE PERSONAL INFORMATION WE COLLECT AND USE: INFORMATION COLLECTED FROM OTHER SOURCES**

We also obtain some of the above personal information from other sources such as credit agencies or sub agents.

## 5. **HOW WE USE YOUR PERSONAL INFORMATION**

We will typically collect and use this information for the following purposes:

- For the performance of a contract you have with our client and pursuant to which we are appointed as their agent.

We seek to ensure that our information collection and processing is always proportionate. We will notify you of any material changes to information we collect or to the purposes for which we collect and process it.

## 6. **WHO WE SHARE YOUR PERSONAL INFORMATION WITH**

We routinely share the following categories of personal data:

- Name, address, telephone numbers, email addresses with our client, contractors, inventory clerks, statutory and local authorities, managing agents for the building, owners/occupiers of adjoining property, porters/caretakers, insurers/loss adjusters.

Personal information may also be shared with the following categories of recipients:

- Client's Solicitors/Debt Collectors  
Client's Accountants  
IT Consultants

This data sharing enables us to perform our contract as managing agent.

We will share personal information with law enforcement or other authorities if required by applicable law.

We will not share your personal information with any other third party.

## 7. **WHERE YOUR PERSONAL INFORMATION MAY BE HELD**

Information will be held at our offices, and third party agencies, service providers, representatives and agents as described above.

We have security measures in place to seek to ensure that there is appropriate security for information we hold including those measures detailed in our GDPR data protection policy.

## 8. **HOW LONG YOUR PERSONAL INFORMATION WILL BE KEPT**

- We will hold such data for the period during which the data subject remains a tenant or guarantor for a tenant and/or we remain the managing agent and for a period of 12 years thereafter.

## 9. **REASONS WE CAN COLLECT AND USE YOUR PERSONAL INFORMATION**

We rely on contract as the lawful basis on which we collect and use your personal data.

## 10. **TRANSFER OF YOUR INFORMATION OUT OF THE EEA**

We do not transfer your personal information outside the European Economic Area (EEA) as follows:

## 11. **YOUR RIGHTS**

Under the [General Data Protection Regulation](#) you have a number of important rights free of charge. In summary, those include rights to:

- fair processing of information and transparency over how we use your use personal information

- access to your personal information and to certain other supplementary information that this Privacy Notice is already designed to address
- require us to correct any mistakes in your information which we hold
- require the erasure of personal information concerning you in certain situations
- receive the personal information concerning you which you have provided to us, in a structured, commonly used and machine-readable format and have the right to transmit those data to a third party in certain situations
- object at any time to processing of personal information concerning you for direct marketing
- object to decisions being taken by automated means which produce legal effects concerning you or similarly significantly affect you
- object in certain other situations to our continued processing of your personal information
- otherwise restrict our processing of your personal information in certain circumstances
- claim compensation for damages caused by our breach of any data protection laws

## 12. **KEEPING YOUR PERSONAL INFORMATION SECURE**

We have appropriate security measures in place to prevent personal information from being accidentally lost, or used or accessed in an unauthorised way. We limit access to your personal information to those who have a genuine business need to know it. Those processing your information will do so only in an authorised manner and are subject to a duty of confidentiality.

We also have procedures in place to deal with any suspected data security breach. We will notify you and any applicable regulator of a suspected data security breach where we are legally required to do so.

### 13. **HOW TO COMPLAIN**

We hope that we can resolve any query or concern you raise about our use of your information.

The [General Data Protection Regulation](#) also gives you right to lodge a complaint with a supervisory authority, in particular in the European Union (or European Economic Area) state where you work, normally live or where any alleged infringement of data protection laws occurred.
